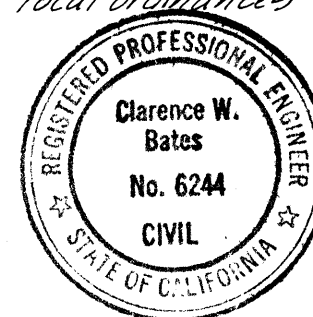

CALIFORNIA

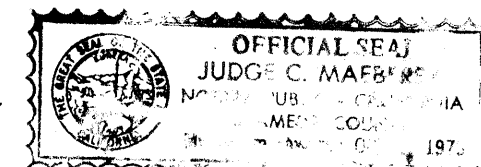

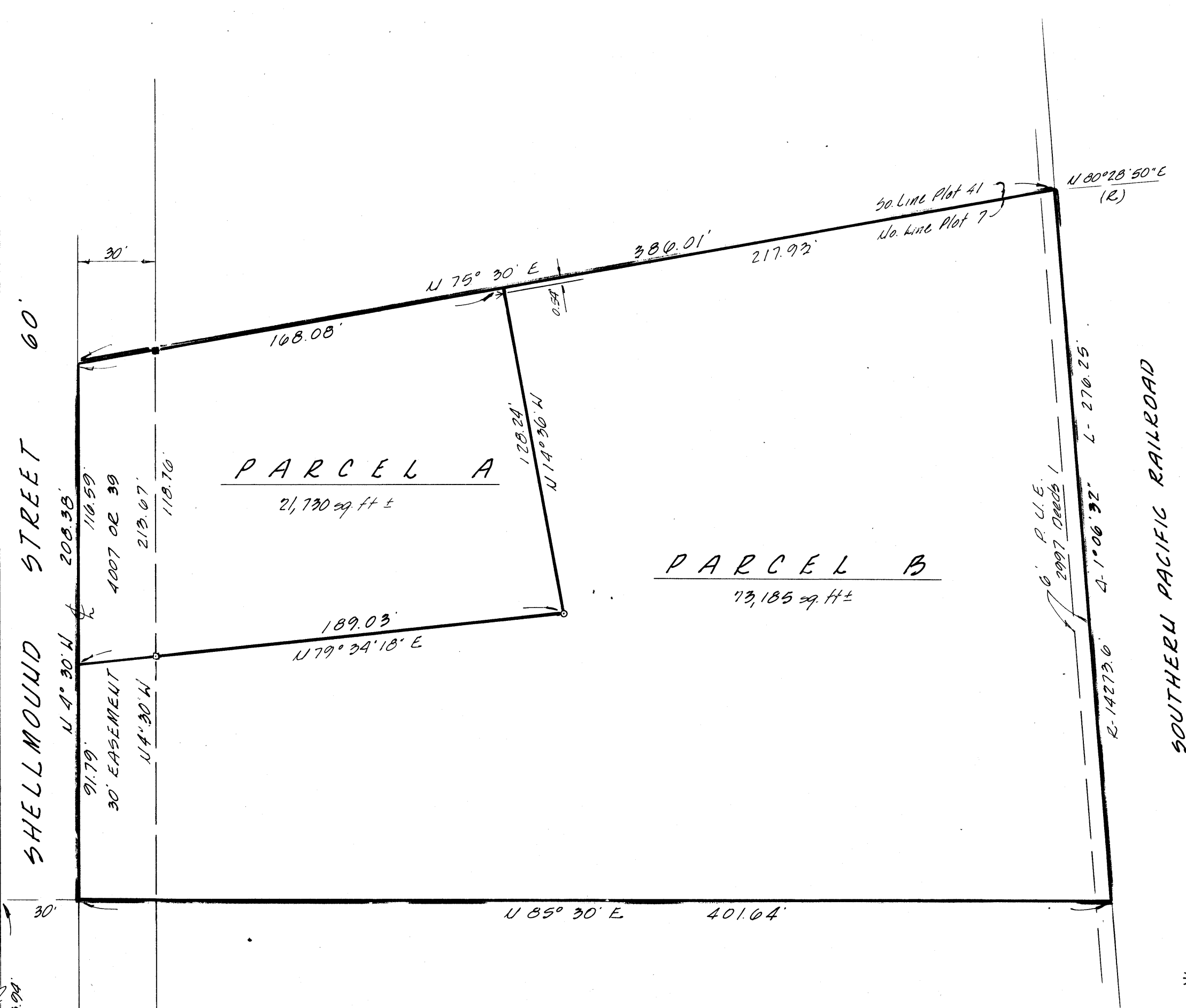
